Country Radio Seminar Exhibit Terms and Conditions

Country Radio Broadcasters, Inc. (CRB) who will be considered "Exhibit Management" for the exposition presents the Exhibit Hall at the Annual Country Radio Seminar (CRS 2017). Any individual who signs an application agreement for CRS 2017 booth space will be acting as agent for their noted company or enterprise and will be considered the "Exhibitor."

The CRS 2017 Exhibit Hall will run from February 22-24, 2017 and Exhibit Management will allot all booth space on a first-come, first-served basis. Exhibit Management will make every effort to satisfy requests for specific booth locations; however, the assignment of all locations will be made solely at the discretion of Exhibit Management. Exhibit Management reserves the right to decline any application or disallow any exhibit that is not in keeping with the character of the exposition, to assign the best alternate space in the event that the Exhibitor's preference(s) are already reserved, and to make reasonable changes in location for the benefit of the Exhibitor or the betterment of the exposition. Exhibit Management reserves the right to alter the Exhibit Hall floor plan and Exhibit Hall hours.

Each Exhibit Hall booth will be provided with draped dividing side rails, one table, two chairs and an identification sign. Each booth space will be 10' x 10'. Access to electricity, audio/visual services, telephones, carpet, furniture, etc. will be available for additional fees. Order forms will be provided once Exhibit Management has received the Exhibitor's application. Exhibit Management must receive the balance on the Exhibitor's booth space by January 5, 2017 or the booth space will be forfeited and a 25% cancellation fee will be assessed. Please make checks payable to Country Radio Broadcasters, Inc. (1009 16th Avenue South, Nashville, TN 37212 (or fill out the credit card info above). For each booth rented, the Exhibitor will receive one (1) Exhibitor Badge. Additional Exhibitor Badges can be purchased. Badge forms will be provided to the Exhibitor once Exhibit Management has received the Exhibitor's application and the booth rental has been paid in full. An Exhibitor Badge will provide the bearer with access to the Exhibit Hall, all CRS 2017 educational sessions, Tuesday Lunch and Friday Lunch. **It does not include the New Faces of Country Music Show and Dinner.** Exhibitor's contact information will be displayed on the official CRS website and in the Official CRS App Sponsorship Page.

Any cancellation by the Exhibitor must be received in writing. A cancellation received on or before December 5, 2016 will receive a full refund less a \$500 per booth administrative fee. A cancellation received after December 5, 2016 will receive no refund and if not already paid and a 25% cancellation fee will be assessed. Upon signing the application agreement, the Exhibitor assumes complete liability resulting from personal injury or property damage caused by Exhibitor action or equipment within the Exhibit Hall and agrees to maintain Broad General Liability Insurance coverage of no less than five hundred thousand dollars (\$500,000). Exhibit Management, service contractors and staff of the same are not responsible for any vandalism, theft, fire or accident to Exhibitor property or personnel. The Exhibitor may not assign, sublet or share space allotted without the written consent of Exhibit Management. The Exhibitor is expected to man or maintain their exhibit during all Exhibit Hall hours. Exhibit Management reserves the right to evict any exhibitor who, in Exhibit Management's opinion, detracts from the general character of the Exhibit Hall. Any audio use in any booth must not be loud enough to disturb adjacent exhibitors and must be approved by Exhibit Management.
